**In a sequence of courses at USC, A B C D, if a student is waived into C, and registers for C, this student cannot concurrently take A or B, nor go back and get credit for A or B later. This is a university rule.**

What to bring to your portfolio review? Bring actual work rather than slides, bring more rather than less, a range of subject matter and techniques, but most importantly, your best work, and work that demonstrates what was taught in the course you took. Do not bring any work based on photographs, magazines, or from work by other artists. If you have questions about what to bring, ask the faculty. **Keep this form with your portfolio.**
